

PATIENT CASE STUDY

ASSESSMENT AND PLAN OF CURRENT VISIT

Cognition: Patient expresses feelings and thoughts about her current placement and the need for her to increase interaction in the community to help with cognitive decline. We will speak with the daughter via phone. Daughter states she would like continued education regarding dementia and assistance in making decisions on continued care whether the patient will remain in a facility or return home. Patient's daughter is proactive and eager to learn as much as possible to help her mother. Patient is alert, but tired. Patient is confused at times, but oriented to person, place and situation, but she is not oriented to time or date. Patient's confusion might be due to her not having her hearing aids in as well as some cognitive decline. We will continue to monitor patient's level of cognition and work on education and support with family and patient.

Complaint: Patient wants to log a formal complaint about her Home Health Aide, Heather. Her car is leaking oil and left a stain in her driveway.

HISTORY OF PRESENT ILLNESS

Patient is a woman being admitted for home care due to St. II Pressure Ulcer to left heel and need for wound management. Patient has significant for type 2 diabetes, hypertension, and nicotine dependence. According to patient's husband, John Smith (contact), she has exhibited no cognitive issues or functional deficits prior to this episode of care. The patient has been noted to have a good appetite and denies problems with sleeping or weight changes. She also denies any suicidal ideations and visual/ auditory issues.

RECOMMENDATIONS FROM CASE CONFERENCE

Patient is improving and meeting her goals, so we should adjust the Plan of Care accordingly. We need to discharge from MSW services next week.
